Field of the Invention This invention relates generally to medical devices and methods. More particularly, the invention relates to a two-piece, pre-shaped, springloaded, disposable stent or graft delivery system, which utilizes a deformable outer sheath and can be crimped, or cold-drawn. The outer sheath outer layer is sufficiently thin and flexible to permit high-pressure fluid flow therethrough, but is strong enough to avoid rupture or tearing. 2. Description of the Related Art Stents and other implantable medical devices, such as grafts, stent-grafts, vena cava filters, catheters, and the like have been developed to maintain, open, or dilate a natural passageway or an artificial passageway in the patient. These devices are typically implanted within the patient using a catheter delivery system. Generally, such catheter delivery systems consist of an elongate catheter and a stent or graft. The elongate catheter can be inserted into the vascular system of the patient and, once the elongate catheter is positioned within the body of the patient, the stent or graft can be delivered to and disposed within the body at a desired location or position. To deliver the stent or graft, it is typically compressed on a distal portion of the catheter so that it has a relatively small diameter and is in a shape suitable for insertion within the patient. One disadvantage of conventional stent or graft delivery systems is that the stent or graft must be compressed to a relatively small diameter (e.g., approximately 6 to 12 French) prior to delivery. However, once the stent or graft has been compressed on the distal portion of the catheter, it must be expanded to the relatively large diameter at which it is disposed within the patient's passageway. To expand the stent or graft, one typically introduces a sheath over the catheter and expands the stent or graft within the sheath. A problem with conventional stent delivery systems is that the sheath is typically too large and not compliant, which can result in undesirable vessel trauma and/or

inaccurate delivery. Thus, there
