Layers define the way that images are edited, and those layers are sorted in a vertical stack, with the top layer on top of the others. Photoshop divides the image into different layers; each layer defines the content of a particular place in the image. (See Chapter 9 for more on layers and layers.)

Delayed syncope following laparoscopy. The majority of women report a typical post-surgical state of drowsiness after a laparoscopy. The Plaintiff has not submitted any sworn allegations demonstrating that the Court of Common Pleas of Erie County has personal jurisdiction over the Defendant. "In order to determine whether the plaintiff has the right to a jury trial under the Seventh Amendment, a Court must ascertain whether it has subject matter jurisdiction over the claim." *Bankston v. Toyota Motor Corp.*, 889 F.2d 172, 175 (6th Cir.1989) (citing *Hanna v. Plumer*, 380 U.S. 460, 469, 85 S.Ct. 1136, 1142, 14 L.Ed.2d 8 (1965)). "There is a strong presumption against the waiver of the Seventh Amendment right to trial by jury." Id. After the completion of jurisdictional discovery, "[d]efendant bears the burden of proving that there is no factual basis for plaintiff's assertion that he was employed by defendant and was not acting as a volunteer." Id. at 176. However, Defendant had the opportunity to conduct discovery and has failed to proffer any facts or evidence in this regard. As the Plaintiff's ability to obtain a jury trial in this matter depends on the Court's personal jurisdiction, the Magistrate Judge recommends that the Plaintiff be allowed a reasonable period of time to conduct jurisdictional discovery. C. The Plaintiff is not entitled to jurisdictional discovery on the issue of whether he was acting as an employee or volunteer. Once the Plaintiff complies with the Court's instructions on jurisd
