It was not covered by Part I of the policy, that being the uninsured motorists coverage. We therefore hold that under the facts in this case the insurance coverage for the accident herein in question was not available to appellant under the provisions of Part I of its insurance policy. 22 Our decision in this case makes it unnecessary to consider the motions of appellees to dismiss as moot. 23 It is apparent, however, that our decision in this case renders unnecessary a discussion of the additional issues raised in the briefs of appellant and appellees on this appeal. 24 Affirmed. Notes: 1 "Policy Form G5000-34C "UNINSURED MOTOR VEHICLE ENDORSEMENT "The policy to which this endorsement is attached is a renewal of a policy which has been issued for the highway automobile hazards only, and which contains an endorsement for uninsured motorist insurance. "It is agreed that the insurance with respect to all automobiles is primary as to such uninsured motorists insurance, except with respect to an automobile, ownership of which is acquired by the insured for his regular use, whereupon such insurance shall become excess over and shall not be applicable to any highway automobile hazards owned by such insured. "It is further agreed that under the provisions of the policy to which this endorsement is attached, the insurance against loss resulting from the liability imposed upon the uninsured motorists for bodily injury is also primary as to such bodily injury, but is excess and not applicable to such injury, as to other damages." 2 See United Services Automobile Ass'n v. Werley, 10 Cir., 379 F.2d 827 3 Uninsured Motorist Endorsement — New and Renewal of Policy "This endorsement modifies insurance provided under the following: "Coverages A, B, D and E of the policy to which this endorsement is attached. "The insurance afforded under this endorsement is only with respect to such of the following coverages as are indicated by specific premium charge. "A. Bodily Injury Liability, to pay on behalf of the insured all sums which the insured shall become legally obligated to pay as damages because of bodily injury, sickness or disease, including death at any time resulting therefrom, sustained by any person. 5ec8ef588b
