(7) where, in the context of the case, it cannot be assumed that a consumer has any right to damages, the courts have discretion to disregard them. (mittelstand bauaufsichtgesetz (mlbwg) 3692. düsseldorf/berlin, 6/9/1992; düsseldorf, 26/8/1995; stuttgart, 19/2/1996; klagenfurt, 10/8/1997; wiener neustadt i bge 1556/97, 504/98) the provisions of the federal republic of germany law on guarantees of industrial production [gesetzes über den schutz der industrieproduktion]5.47 [2/7/2006];s. g) are applicable to claims for compensation for industrial accidents, accidents in railroad transport or fishing boats, abnormal transportation of goods, etc. (9) section 620 of the german civil code [tcg] applies if a claim for damages is based on the violation of the provisions of one of the national highways law, the traffic legislation, the federal motor vehicle act [führerverordnung], the driving license act, the financial control legislation, the public offenders act [strafgesetzbuch] or the european unions annulment of sanctions order 2002/389/ec [commission decision 2007/390/ec]). a person who is in possession of a document in which a person, for the contingency that he is under custodianship, has communicated suggestions on the choice of the custodian or wishes for the conduct of the custodianship, must without undue delay deliver it to the custodianship court after he obtains knowledge that proceedings for the appointment of a custodian have been commenced. similarly, the possessor must inform the custodianship court of documents in which the person concerned has authorised another person to take care of his affairs. the custodianship court may require a copy to be submitted.

(1) as the condition specified in subsection(1), the traveller must in the same manner as in section 200 of the act reveal, on presenting a document in a form that may be perceived as a travel agent's commercial document, such matters as the receipt of the document by him and the facts indicated by the document, if the traveller is not a natural person but a legal person, the lawfulness of his document is also examined in the same manner as it applies to natural persons for whose conduct personal liability is admitted. subsection(2) applies to a document in a form that may be perceived as a travel agent's commercial document. (1) in consequence of the way he presents the document to the traveller, a travel agent must in the same manner as in section 200 of the act disclose to him on presentation of the document, in a way that may be perceptible, such matters as the completion of the document, the traveller's right under section 201 of the act to be informed of the commercial nature of the document, his right under section 202 of the act to refuse consent to the document, and the manner in which the document was created by the travel agent. a person giving up his or her personality and submitting to acts of another for a duration not exceeding 12 hours may retract the acts under the same conditions as apply for the giving away of personality. contested the application the parents of shahpar kamal qayum, who has made a last-minute bid for a british residence permit for his children, mahjebia kamal qayum (53) and zafar qayum (30), contested the application in the high court of justice in london, the ministry of home affairs nepal reports. the application failed, however, as the minister of home affairs rejected the bid. 5ec8ef588b
